1. Parofor® powder 70,000 IU of paromomycin activity (as paromomycin sulfate). Parofor® powder is licenced for the treatment of gastro-intestinal infections caused by *Escherichia coli* susceptible to paromomycin in pre-ruminant calves and pigs. Duration of treatment should be 3-5 days and for re-ruminant cattle a dose of 17500 – 35000 IU (equivalent to 25-50 mg paromomycin sulfate) per kg BW/day should be used.
2. Parofor® 140 mg/ml solution for use in drinking water, milk or milk replacer for preruminant cattle and pigs. Parofor® 140 mg/ml solution is licenced for the treatment of gastro-intestinal infections caused by *Escherichia coli* susceptible to paromomycin in pre-ruminant calves and pigs. Duration of treatment should be 3-5 days and for re-ruminant cattle a dose of 25-50 mg paromomycin sulfate per kg BW/day should be used.
3. Parofor® Crypto® 140 mg/ml oral solution for non-ruminant calves contains paromomycin sulphate. Parofor Crypto® is licenced for the reduction in the occurrence of diarrhoea due to diagnosed *Cryptosporidium parvum* in pre-ruminant calves. Dose rate: 35 000 IU (equivalent to 50 mg of paromomycin sulfate) of paromomycin/kg BW/day for 7 consecutive days.
4. Parofor Crypto® sheep and goats 140 mg/ml oral solution for non-ruminant sheep and goats, contains paromomycin sulphate. ParoforCrypto® sheep and goats is licenced for the reduction in the occurrence of diarrhoea due to diagnosed *Cryptosporidium parvum* in pre-ruminant sheep and goats. Dose rate: 35 000 IU (equivalent to 50mg of paromomycin sulfate) of paromomycin/kg BW/day for 7 consecutive days.
5. HuveCheck® Calf Scours 5 is a point of care rapid test to detect rotavirus, coronavirus, *E.coli* (K99, CS31A) and *Cryptosporidium parvum* in faeces. HuveCheck® Crypto is a semi-quantitative test for detection of *Cryptosporidium* in faeces.
